



Travel and subsistence expenses for the period of 1 April 2017 to 31 March 2018 (Judges of the Court of Session and High Court of Justiciary)

Senators are required to go on circuit from time to time, meaning that they sit in various courts throughout Scotland. Depending on the distance from Edinburgh (location of Senators' base court) they may reside in accommodation near the court or travel daily.

The table below details the travel and subsistence costs incurred by Judges of the Court of Session and High Court of Justiciary in carrying out their duties for the above period.
